Announcing the 2023 New England Architecture & Friendly Firm Awards

(New Haven, CT; November 15, 2023) Each year one of the New England Chapters of the American Institute of Architects hosts the annual New England Architecture Awards (formerly the AIA New England Design Awards), recognizing the diverse architecture of New England architects and architecture. In 2018, the AIA New England region introduced the New England Emerging Professional Friendly Firm Awards. This awards program aims to identify firm initiatives that promote the advancement of young professionals through development and personal growth opportunities.

The Connecticut Chapter of the American Institute of Architects (AIA Connecticut) had the honor of hosting a dinner for this year's awards as part of their annual Connecticut Architecture Conference + Expo. The celebration was held on October 26th at Mystic Marriott in Groton, CT. The awards dinner Keynote Speaker was Evelyn Lee, FAIA, recently elected as the 2025 President of the American Institute of Architects.
